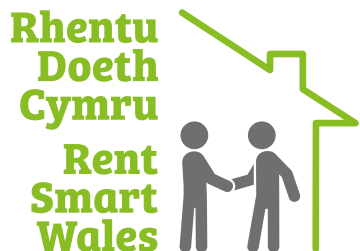


# Training options for licensing

# About training

Training courses can be completed directly with Rent Smart Wales. A list of course options are shown below. Alternatively courses can be completed through approved and authorised External Training Providers. Their details can be found [here](#).

To submit a valid licence application, training (except Continuing Professional Development (CPD) training) must have been completed within **1 year prior** to the application submission date. CPD training can be completed **over the 5 year duration** of the previous licence.

Training evidence must accompany a licence application and licence fee, in order for Rent Smart Wales to grant a licence.

Landlord and agent training requirements are different to reflect the additional obligations held by an agent.

## Training options for your first licence

If an applicant is applying for their first licence, they must pass a **Landlord/Agent Licence Training** course (see page 3)

## Training options for renewing your licence

There are three training options available at renewal. These include:

1. **Repeating the Landlord/Agent Licence Training (see page 3)** – to be completed within 1 year prior to the application submission date; OR
2. **\*Re-licensing Training (see page 3)** – to be completed within 1 year prior to the application submission date; OR
3. **\*Continuing Professional Development (see page 5)** – The applicant must achieve a minimum number of CPD points before submitting the renewal application. A landlord must achieve 60 points and an agent must achieve 80 points. CPD courses are each weighted differently depending on whether they are a core (mandatory) or supplementary (of the applicant's choice) course. This option must be completed over the 5 year duration of the previous licence

*These options only suitable for those who have previously completed approved 'first time' licence training*

## Complete courses

These courses are the equivalent to one-day intensive training.

<b>Re-licensing training</b>	Online	Renewal only	<ul style="list-style-type: none"> <li>• Those applying to renew their licence</li> <li>• Connected persons on a licence for a charity/ trust/ corporate body landlord or those working for a charity/trust/corporate body that manage properties on behalf of landlords</li> <li>• Those who would still like to do 'complete' training but focus on more relevant topics relating to day-to-day management of a a tenancy rather than all the topics covered in the initial licensing training</li> </ul>

## Supplementary (top-up) courses

Depending on the licence type, you may be required to add 'supplementary' courses to 'complete' courses (listed above) to make up the training requirements.

<b>Agent Top-Up from Landlord Licence Training</b>	Online	Initial licence and renewal if combined with relevant 'complete' course above.	<ul style="list-style-type: none"><li>• Those who have completed approved training that require this top up (information can be found on our external training page)</li><li>• Those who have completed Rent Smart Wales Landlord Training Online and require a top up in order to apply for an agent licence</li><li>• Those who have completed a classroom based Rent Smart Wales Landlord Training Course and require a top up in order to apply for an agent licence</li></ul>

## Continuing Professional Development (CPD) courses

CPD courses provide more choice in timing, subject and delivery environment. Each CPD course is weighted differently, depending on whether they are a **‘Core’** (mandatory) topic or **‘Supplementary’** topic (of the applicant’s choice).

### Core CPD Courses (must be completed to submit a valid licence application based on CPD training)

Safe and healthy homes	Online	Renewal only	30
Tenant Fee Ban (mandatory for agents only)	Online	Renewal only	10

*\*Courses are only suitable for renewal if they add up to the required number of points needed for renewal.*

### Supplementary CPD Courses (pick and mix from below to combine with a Core CPD course to achieve the required number of points):

Mental Health Awareness	Online	Renewal only	10
